

#### **OPPORTUNITY TO DISPLAY AND SELL PAINTINGS**

Beginning May 1, the Guild has an opportunity to display and sell work on the walls of Made in Milwaukie, an art store at 2026 SE Monroe St. in downtown Milwaukie. Guild members pay 30% commission to the store, which is very reasonable considering 7-day exposure for 90days, and extra foot traffic generated by the nearby Milwaukie Sunday Market. Jerry Schmidt has created several new signs to attract buyers. In June, we expect the renewal of the First Friday art walk tradition in Milwaukie, which will increase the opportunities for our artwork to be viewed and purchased.

The store is owned and operated by Rob Campbell and Chris Haberman, who have been in business here for 3 years. They feature everything in visual arts from silk-screened shirts, to jewelry, sculpture, and PAINTINGS! If Guild members wish to bring paintings in to sell, contact Pam or Connie for paperwork and signup. We do have size limitations, so to maximize the number of pictures we can hang, 16x24 is probably the biggest we should

offer.
